Liberty Mutual Insurance Completes Acquisition to Become Largest General Insurer in Chile and Names Fernando Cámbara Lodigiani CEO of Chile Operations

January 14, 2016 - Liberty Mutual Insurance, one of the largest property and casualty insurers in the world, today named Fernando Cámbara Lodigiani as CEO of its Chile operations following its acquisition of approximately 99.6% of Compañía de Seguros Generales Penta Security S.A.
